UPDATE ON NATIONAL GRID, FIVE ESTUARIES, NORTH FALLS AND TARCHON PROPOSALS

Tendring District Council's Full Council meeting took place on Tuesday 6th August where Cllr Zoe Fairley proposed, and Cllr Carlo Guglielmi seconded the following motion:

Motion to Council Pursuant to Council Procedure Rule 12 - Concern regarding Electricity Network Proposals

"This Council notes that the National Grid Electricity Transmission's (NGET) third and final statutory consultation has now closed and that the consultation response from this Council was submitted prior to the extended closing date of 26 July 2024.

This Council is fully aware that National Grid's proposals could also create and cause the need for the Five Estuaries, North Falls and Tarchon Energy Ltd projects to land on the District's coast, with their own proposed cable routes running across our District to their own sub-stations and for Tarchon Energy Ltd, a future interconnector will be required. The cumulative impacts of these projects threaten a potentially devastating effect for our District.

This Council therefore remains dissatisfied that alternative options have not been given due and proper consideration in the planning process to date to remove or otherwise mitigate these effects, including impact on our highways, our local economy, the environment, our landscapes and heritage, farm businesses and the health and wellbeing of our communities, to highlight but a few.

This Council recognises that the country has had a change of Government and a new Secretary of State for Energy Security and Net Zero appointed, in Ed Miliband MP.

Therefore, this Council continues to express its deep concerns for these electricity network proposals, and calls upon the Leader of the Council to write to the Secretary of State for Energy Security and Net Zero, Ed Miliband MP to:-

- a) Congratulate him on his appointment.
- b) Request him to consider, as a long-term strategic solution, an integrated off shore grid, as elsewhere in Europe, asking for the overall cost comparison to be assessed and reported.
- c) Request that he re-examines the Norwich to Tilbury proposals, given that North Falls and Five Estuaries have expressed themselves more than happy to connect off shore and National Grid's Electricity System Operator (ESO) has identified affordable, deliverable alternatives to manage the case.
- d) Request also, that the Tarchon interconnector should not be allowed to proceed at all, given the work by ESO and Arup, demonstrating that it is against the National Interest and raises costs for UK bill payers by some £5billion.
- e) Point out that HVDC undergrounding, which is also being done in

Germany, has been assessed by National Grid Electricity Transmission (NGET), as being better and cheaper than pylons, within its Eastern Green Link Consultation (see para 5.0.2 in below link) and request the same should be investigated for Norwich to Tilbury. https://www.nationalgrid.com/document/151426/download

f) Request, that further to ESO modelling, to make best use of power available in the East of England, he considers upgrades to reinforce the existing grid, to include options such as TS Conductors' technology, which is being prioritised in policy in the USA; enable use of existing brown field sites as landing points; and considers North Falls and Five Estuaries connecting to an offshore cable, such as Sealink.

In addition, this Council calls upon the Leader of the Council to write to Sir Bernard Jenkin MP for Harwich and North Essex and Nigel Farage MP for Clacton, including a copy of the letter sent to Secretary of State for Energy Security and Net Zero, Ed Miliband MP, requesting them each to consider and take all possible actions open to them, as our Members of Parliament, to support this Council's position."

Cllr Fairley further went on to introduce the motion with below:-

"Around our coast, for East Anglia and Essex, we are host to some of the largest and most valuable wind farms to date and I think it is safe to say that most people support the over-arching aim of reducing our reliance on fossil fuels and look forward to producing and using more renewable energy. I certainly do.

However, the piecemeal delivery for offshore developers to reach connections given by National Grid at their proposed East Anglian Connection Node substation at Ardleigh, under the Nationally Significant Infrastructure Project process, is unnecessarily damaging for our communities. The 2031 'fully operational' target date for National Grid's proposals, on which the 'hoped for' benefits for their project are based, is also highly unlikely, if not impossible to achieve.

There are other options which would support the UK's aims to increase renewable energy delivery for these, and future offshore projects, which have not been consulted on, but could be far better for Tendring, the broader Norwich to Tilbury route, and the UK as a whole. Since 2011, three independent studies have demonstrated that offshore coordination saves money and is better for the environment and communities.

By bringing their East Anglian Connection Node sub-station to Ardleigh, to enable connections for Five Estuaries, North Falls and Tarchon Energy, National Grid will cause our District to be ripped apart. The cumulative impacts will be devastating. And it is urgent, because economic damage, due to this piecemeal process, is already happening to our farming businesses now. There is also the untold story of impact on mental health for stress, anxiety and depression related directly to these projects.

Within any debate, it is important to remember that we, as Councillors ALL want to do the best we can for our District, whatever side of the chamber we sit. This motion is asking questions and showing evidence for conflicting information and

opinion on the logic of National Grid's approach to the Norwich to Tilbury upgrade and also questions the supposed National Significance of the Tarchon Interconnector. Some of this conflicting information is from National Grid themselves, and other, from industry experts such as Arup.

Tendring District Council is not the decision maker in this case, so as Councillors, we do need to do all we can to ensure that these delivery plans are cohesive and well thought out. We need reassurance, that the base information for any final decision, is right, and that any consequences, for our District and residents, are fully taken into account. IF hosting this infrastructure across our District really is the best way forward, and brings benefit to every UK consumer, then this needs to be demonstrated. Because just saying something IS, does not make it so.

Following the new Government's announcement, on 25 July, that it will support the Crown Estate to grow the offshore wind industry, it is even more vital, that a long term, strategic solution, which can improve the UKs chances of reaching net zero in a timely manner, takes the environmental, social, economic, and health outcomes of our communities into account, AND speeds up future connections for offshore wind farm development, is properly considered and achieved. National Grid's Great Grid Upgrade, Norwich to Tilbury proposals, and the need for their East Anglian Connection Node substation, should be considered within this process.

Other options are possible to deliver renewable energy in ways which the public are willing and confident to support. To make the best use of power available in the East of England, fully considering those options, and implementing the best long term solutions, will also help speed up overall project delivery. Residents, business owners, Parish, Town, District, City and County Councils will be far more likely to support. Rash, emergency decisions, to meet unlikely date targets which unnecessarily devastate our farms and District are not the way forward.

And so, I would ask you to support my motion."

And after discussion, finished with comments as below:-

Thank you everyone for your comments. There is a huge amount of concern.

The level of objection across the 184 kilometre route is unprecedented. The impacts are too severe.

There's a huge amount of work, to reach Net Zero. And we ALL see projects will need a massive amount of infrastructure. But it's got to be done in the right way.

Peoples' concerns aren't Nimbyism or reported Climate Delivery Denialism; They're genuine fears, that this delivery plan, is not the best way.

National Policy Statement EN5, updated in January this year, states that even residual impact is unacceptable and highlights the need to use alternative routes where they are available, even if they cost more.

Affordable, deliverable alternatives to the current proposals HAVE been

identified.

Whatever transmission infrastructure there is, communities and farmers should not have to bear the burden, without proper compensation.

We live in the Bread Basket of England – called so, because it is the best food production land in the UK. Farmers aren't against progress; services with wayleaves, cross agricultural land all the time. But these routes, with more to come, leave farmers in an impossible position for planning. Where acres are permanently taken, farms become unviable.

Rural communities will be lost. The impact across Tendring for construction, on highways, and our economy, will be severe.

An integrated offshore grid must be considered.

Although HVDC undergrounding may have a greater initial cost, lifetime costs are less.

I'd like to finish by saying this. It's beneficial for our Planning Committee to carry out site visits prior to determining a planning application. This should be the same.

Ardleigh and Little Bromley are where Five Estuaries, North Falls and Tarchon have been given connections to National Grid. So I'd like to extend a personal invitation to Mr Miliband, to visit my ward before the project proceeds any further, to better understand my residents' concerns; that's open to both our MPs as well.

I am pleased to say, the motion received unanimous support and I will be liaising with the Council Leader, Mark Stephenson, Cabinet Member Andy Baker, with Officers to agree the letters to be sent.

Also for your information, below is content for an email letter, sent on 26 July 2024 by Cllr Graham Butland, Leader of Braintree District Council and Chair of ELCE, representing the views of 15 Council leaders in Greater Essex.

Dear Mr Pepper

Norwich to Tilbury – statutory public consultation by National Grid Energy Transmission Limited

This letter represents the views of the 15 Council leaders in Greater Essex. This letter is written in response to the current proposals by National Grid Energy Transmission (NGET) to introduce new overhead pylons the length of our county. This letter is in addition to the individual consultation response you will receive from each local authority.

Whilst we understand the need to upgrade the existing supply network and transition to clean energy sources, the proposals as planned are simply not good enough as presented. They require much more work which the Hiorns report identifies there is time to do. We strongly object to what is proposed. Much more work is needed before this package of proposals should be submitted for

examination by the Planning Inspectorate. The impact and the scale of the proposed development, including the construction and development phases, have not been adequately considered or have the mitigation measures identified. The proposals as presented are also bereft of any social value.

Leaders in Greater Essex have the following in-principle objections to the N2T proposals:

- Object to the lack of evidence provided by NGET to support the need and timing of the Norwich to Tilbury scheme being needed by 2030.
- Object to NGET undertaking an accelerated programme of consultation to meet an uncertain 2030 programme delivery date on what is considered to be a predetermined strategic proposal and 2024 preferred draft alignment using predominately harmful OHL and pylon technology, and prior to the conclusion of the Offshore Coordination Support Scheme (OCSS) and consideration of Hiorns Smart Energy Network Report (November 2023) and Electricity Systems Operator (ESO) East Anglia Study Report (March 2024).
- Object to the lack of consideration by NGET to the creation of beneficial social value outcomes in Greater Essex that relate to reducing geographical inequalities in education, skills, supply chain, employment, and climate action.
- Object to the lack of consideration by NGET to a package of financial benefits for local communities in Greater Essex to support equity of engagement in the development consent process and that recognises the vital role that local communities have in hosting energy infrastructure in the national interest of securing cheaper, greener, and more secure electricity.

In addition, we raise a strong technical objection to the lack of assessment by NGET in relation to the likely significant impact the preferred route will have on the viability and therefore deliverability of Dunton Hills Garden Village and the adjacent land west of Basildon (being considered in relation to the new Basildon Local Plan). The solution is, to place the grid network underground for the entire length of the route as it passes through the Garden Village, thereby mitigate the impact.

Particular attention is also drawn to the level of disturbance expected in the construction phase, where we would like further attention and detail, as well as minimise and address the impact of the proposed 400 kV substation planned for the Tendring peninsula.

TDC's response for NG's statutory consultation which has already been shared on 23 July in the PP&LP Committee reports, was submitted prior to the closing date of 26 July 2024 following the Planning Policy and Local Plan committee meet. This response was also formally reported at yesterday's Full Council meeting.

GREAT BENTLEY DOCTORS' SURGERY

We are fast approaching flu vaccination season and I want to take this opportunity to remind everyone who is eligible, that we will start to book appointments for this in early September. Text messages will be sent out inviting patients to book via a link, or alternatively they can be booked by calling the Surgery on telephone 01206 250691. Flu vaccinations will be available this year for all patients aged 65 and over and those under 65 with chronic health conditions.

As per very specific instructions from NHS England, we will not be able to start our Flu Clinics until October. We will of course continue to provide vaccinations opportunistically during normal routine appointments for eligible patients, so there is no need to book a separate flu appointment if you are seeing a clinician for a face-to-face appointment after the 1 October 2024.

Flu is an unpredictable virus that can cause mild or unpleasant illness in most people, BUT it can cause severe illness and even death among vulnerable groups including older people, pregnant women and people with an underlying health condition. If you are not sure if you are eligible, please give us a call. We are unable to provide private vaccinations, but many local pharmacies do.

By having your flu jab, you are not only helping yourself, but you are also helping to protect the wider population from this nasty virus which can easily spread to vulnerable people who are much more at risk from complications.

Autumn Covid Booster

The autumn Covid boosters will not be administered by the Surgery this year. At the time of writing this Newsletter, we do not have details of where patients will be able to attend to get their booster. We will however keep you updated once we have further information about this.

New RSV Vaccination

From the 1 September 2024, a new respiratory syncytial virus (RSV) vaccination will be introduced which will help to fight respiratory infections. To start with, the following patients will be entitled to this vaccination:-

Programme for older adults aged 75 to 79 years old

All adults turning 75 years old on or after 1 September 2024 will be eligible for the routine programme and should be offered a single dose of the RSV vaccine. A one-off catch-up campaign for those already aged 75 to 79 years old on 1 September 2024 will be undertaken at the earliest opportunity

Programme for pregnant women to protect infants

All women who are at least 28 weeks pregnant (the eligible cohort) on 1 September 2024, will be offered a single dose of the RSV vaccine. After that, pregnant women will become eligible as they reach 28 weeks gestation and remain eligible up to birth.

All patients who are eligible for the new vaccination will be invited by the Practice to book in for this.

AskmyGP – New Digital Platform We implemented the digital platform AskmyGP on the 16 July 2024. I am pleased to report that in the first two weeks of using this service over 20% of our patients have registered for the digital platform.

For those patients that have access to the internet and haven't registered with this service yet, we would ask that you sign up for this service by going to our website

www.greatbentleysurgery.nhs.uk. Once on the website you need to scroll down to the green box which says 'get help now' and then click on submit a new

request. It will then allow you to register on the system. Our reception team are happy to give advice to patients about registering with AskmyGP and also have leaflets to give to patients visiting the Surgery.

Sept 10th

The Deanery Choir will be singing at St Georges Church, Great Bromley CO7 7HZ at the 10.30am communion service. The anthem that they will be performing is, 'Almighty and everlasting God' by Orlando Gibbons.(1583-1625) Gibbons was an English composer and keyboard player who was one of the last masters of the English Virginalist School and English Madrigal School. The best known member of a musical family dynasty, by the 1610s he was the leading composer and organist in England, with a career cut short by his sudden death in 1625. As a result, Gibbon's oeuvre was not as large as that of his contemporaries, like the elder William Byrd, but he made considerable contributions to many genres of his time. He is often seen as a transitional figure from the Renaissance to the Baroque periods. Gibbons was born into a musical family where his father was a wait, his brothers - Edward. Ellis and Ferdinand were musicians and Orlando was expected to follow the tradition. It is not known under whom he studied, although it may have been with Edward or Byrd, but he almost certainly studied the keyboard in his youth. Irrespective of his education, he was musically proficient enough to be appointed an unsalaried member of the Chapel Royal in May 1603 and a full-fledged gentleman of the Chapel Royal as junior organist by 1605. 1606 he had graduated from King's College, Cambridge with a Bachelor of Music degree.

Sept 24th

The Deanery Choir will be singing at All Saints Church, Walton-on-Naze CO14 8BU at the 4.00pm Choral Evensong service. The anthem that they will be performing is, 'View me Lord' by Richard H Lloyd. (1933-2021) After National Service he was organist and choirmaster at SHAPE near Paris. From 1957 to 1966 he was assistant organist of Salisbury Cathedral under Christopher Dearnley. In the year 1966 he was appointed Organist and Master of the Choristers of Hereford Cathedral. He was chief conductor at the Hereford Three Choirs Festival in 1967, 1970 and 1973. In 1974 he moved to Durham on his appointment as Organist and Master of the Choristers of Durham Cathedral. In 1985 he became deputy headmaster of Salisbury Cathedral School. III health forced his early retirement in 1988.

Did you know? Great Bromley has two Automated External Defibrillators. You can access these at:

- The Courthouse, Harwich Road, CO7 7JG or
- The Cross Inn, Ardleigh Road, CO7 7TL

Also at the Cross Inn is a Bleed Kit. The kit, provided by Great Bromley Parish Council, contains specialist equipment to help stem extreme blood loss before ambulance crews arrive.

Bleed control kits, also known as emergency trauma packs, are similar to first aid kits but include trauma dressings, gauze, chest seals and tourniquets to help stop serious bleeding. They can help victims of violent crime, those involved in road traffic accidents or workplace accidents, and could be particularly useful in rural areas where ambulance response times may be slower.

Essex Highways carry out regular inspections of roads and pavements, but issues may come up between these inspections. These could be potholes or other road surface issues, damaged street lights, street signs, overgrown trees, or issues with public rights of way.

Report maintenance issues online by using the highways reporting tool. If you think there's a risk to public safety please call 0345 603 7631 or if you have hearing problems you can use the text phone service on 0345 758 5592.

KATHY HAYWARD 1955 - 2024

Kathy was the daughter of Val and Dick Hayward who, with her brothers John and Jamie, moved from The Walnut Tree in Great Bromley to Badley Hall Farm. She attended St George's Primary School and the Gilberd School in Colchester. During her time on the farm she developed a lifelong interest in animal welfare and she left the village to train as a veterinary nurse at a London college. However she much preferred living in the countryside and returned to Great Bromley.



In her early 20s she made two overland trips to India, firstly on the 'Magic Bus' and then again by hitchhiking in 1978-9. During this second trip she

travelled extensively and walked in the Himalayas, visited the Golden Temple and cycled down the West Coast. These two trips to India had a profound impact on her values and beliefs. After her return she lived at Fir Tree Cottage with her partner Con Rendell, where she carried out what she regarded as her most important role as mother to her five children, Tom, Fen, Rowany, Lucia and Alf. After she split from Con, she worked as a housekeeper at Flatford Mill and devoted considerable time to caring for her relatives in their later years and took great pride in her two grandchildren, Joseph and Ella.

She loved music which started when she learnt the piano and developed through playing music with her family and friends. She had a strong belief in the power of nature and the need to protect the environment, so she gladly gave time to being the village tree warden and cleaning up local rivers. She took great delight from living close to nature in her garden and the surrounding woods and particularly enjoyed bird watching and spending time on the River Stour with her friends.



Kathy had lived almost all of her life in the village until her death at home at Fir Tree Cottage at the age of 69. She was always very stoic about her cancer which she thought had been cured in her mid 40s, but then reappeared in her mid 60s. It was very fitting that her family and friends met at one of her favourite places at Wrabness Nature Reserve to scatter her ashes on her beloved River Stour whilst one of her friends played a tribute on the flute. She will be much missed by her children, grandchildren and brothers along with her many friends.

Leonard Cheshire Hello Great Bromley,



RECTOR'S LETTER

Dear friends,

As we begin a new month and our children head back to school, memories of our summer holidays are slowly pushed out of our minds by the constant demands of daily life. And as we turn on the telly, read the paper or listen to the news we are reminded of nations at war, hostage situations and assassinations in the Middle East, an attempted assassination in the US and stabbings and riots in our own country. Amidst all this, it's worth considering the question: How do we deal with the reality of life in all its busyness, in all its brokenness?

Christians have traditionally brought these things to God in prayer. The Apostle Paul wrote to one of his protégés, Timothy: "I urge, then, first of all, that petitions, prayers, intercession and thanksgiving be made for all people – for kings and all those in authority, that we may live peaceful and quiet lives in all godliness and holiness" (I Timothy 2:1-2). Paul knew that being able to "live peaceful and quiet lives" was no automatic right or certainty in his day – that we would need to pray for all those in authority, for those whose actions

can, at one level, start or stop the conflicts that mar life in this fallen world.

But prayer is not just "for kings and all those in authority", because Paul elsewhere addresses the internal strife, stress and strains that can, at times, overcome each of us: "Do not be anxious about anything, but in every situation, by prayer and petition, with thanksgiving, present your requests to God. And the peace of God, which transcends all understanding, will guard your hearts and your minds in His promised King Jesus." (Philippians 4:6-7) – that is, the path to inner peace was a prayer-filled one.

So how do we deal with the reality of life in all its busyness, in all its brokenness? Maybe today you say a prayer (which is just talking to God – it doesn't need to be anything fancy) amidst the busyness of your own life or in light of the brokenness that you see around you. God is in control – He can do something about it – and He made you, so He loves to hear from you.

May you know His peace at this time.
