

The Parish Council has recently co-opted our last two vacancies, with James Pirie and Bashir Goni joining us. We welcome you both and look forward to your contributions.

Going forward, all parish councillors and the clerk will be using official .gov.uk email addresses. This is part of strengthening our data protection and governance arrangements, as required by national audit standards. Using .gov.uk addresses helps ensure council business is kept secure, traceable, and separate from personal email accounts, which is an important element of Assertion 10 in the Annual Governance and Accountability Return. The website address has also been updated with an automatic redirect in place.

A sub-committee, established to consider the 2026-27 budget, has met twice to explore how best to maintain standards and meet expectations in a cost-conscious manner. After careful discussion, the Council agreed a 13.2% increase, setting the precept at £38,150. In absolute terms, this represents an annual increase of £10.07 for the average Band D household.

Our monthly meetings include a public participation slot, where residents are welcome to raise concerns or issues the Parish Council may be able to assist with. At our January meeting, a group of residents used this opportunity to express concerns about a planning application to change a private house into a commercial property for the care of children. The Parish Council

recognised these concerns and, after discussion, supported the objection. You can read the objection in full on the Parish Council website, www.greatbromleyparishcouncil.gov.uk

Over the Christmas break, the village maintenance team were busy addressing several tree-related issues identified in our annual inspection of all trees under Parish Council responsibility. Work included trimming a large bough overhanging the school playground and removing dead branches from trees in Church Meadow while it was closed for the annual 24-hour period to protect the private rights associated with the churchyard. This brief yearly closure is a legal requirement that helps preserve the historic rights of access and ownership attached to the land. By closing it once a year, the Parish Council ensures that these rights remain clearly defined and cannot be lost or challenged over time.

Finally, as many of you will have noticed, we have had a significant amount of rain recently; 71mm in the last 30 days. The ditches around our lanes are essential watercourses designed to move water away from the surrounding area. They are not the place for old Christmas trees, garden waste, or any other rubbish. Blocking these ditches can cause flooding and may even result in water entering someone's home. We also ask everyone to take pride in the village and pick up any litter you see blowing around, and to dispose of household waste responsibly.

The Deanery Choir will be singing at St Georges Church, Great Bromley CO7 7TS at the 11am communion service.

The choir will sing 'Lord, make me to know thy ways' by William Byrd. Byrd (1540 – 1623) was an English Renaissance composer considered among the greatest composers of the Renaissance, he had a profound influence on composers both from his native country and on the Continent. He is often considered along with John Dunstable and Henry Purcell as one of England's most important composers of early music.

In 1577, the same year that recusancy (the refusal to attend Anglican services) laws began to be enforced, Byrd and his family moved to Harlington, Middlesex. As a devout lifelong Roman Catholic, he probably preferred the greater privacy of living outside London. Yet, in spite of his close social contact with many other Catholics, some of whom were

certainly implicated in treasonable activities, his own loyalty to the government was never questioned.

Also in 1591 a manuscript volume of Byrd's keyboard music was prepared for "my Ladye Nevell" (probably Elizabeth, wife of Sir Henry Neville), and many more keyboard pieces found their way into the early 17th-century volume known as the *Fitzwilliam Virginal Book*, copied by another well-known Catholic, Francis Tregian, during his imprisonment in the Fleet Prison.

PLANNING APPLICATION

REF	PROPOSAL	LOCATION

Great Bromley Parish Council objected to the application for the following reasons:

1. Policy Context – LP10

Policy LP10 of the Tendring Local Plan supports, in principle, the provision of new care units within defined settlement boundaries. The site lies within the settlement boundary of Great Bromley, and therefore the principle of a care home use is acknowledged. However, LP10 also requires that proposals do not harm residential amenity, provide adequate parking, and respect the character of the village. On these grounds, the proposal is deficient.

2. Loss of Safeguarded Open Space – Policy HP4

The proposal seeks to extend hardstanding at the front of the property, cutting

into land identified as Safeguarded Open Space in the Local Plan.

Policy HP4 states that such space should only be lost where it is replaced in kind, no longer required, or where its loss would not harm visual amenity.

The verge in front of the site contributes to the open character at the centre of Great Bromley. Its reduction would erode the village's visual amenity and character.

The proposal therefore conflicts with Policy HP4.

3. Car Parking Provision and Highway Safety

The management plan indicates:

- Up to 3 children accommodated.
- Two carers on shift at all times, with overlap periods.
- A registered manager and a team of carers on rota.
- Based on Essex Parking Standards, the site should provide:
- 1 space per full-time staff member (minimum 5 spaces).
- 1 visitor space per 6 beds.
- Total requirement: at least 6 spaces with turning provision.

The application form states 7 spaces, but the submitted plans do not clearly demonstrate how these can be accommodated. The layout appears cramped, with insufficient turning space to allow vehicles to enter and leave in a forward gear. This raises highway safety concerns and conflicts with LP10's requirement for adequate parking provision. The parking opposite is on private ground and used by the village school and church, the proposal fails to demonstrate compliance with policies CP1 and CP2 which states the application should not give rise to unacceptable highway safety impacts or congestion.

4. Impact on Village Character

Large areas of hardstanding and multiple parked vehicles at the front of the property would be visually intrusive and harmful to the character of the village street scene. This impact conflicts with both LP10 and HP4, which seek to protect local character and amenity.

5. Residential Amenity

While the number of residents is comparable to a large family, the intensity of staff movements, shift changes, and visiting professionals will increase vehicle activity and noise. This has potential to disturb neighbouring properties contrary to LP10's requirement to protect residential amenity. This application would significantly intensify activities materially different from a private dwelling, this application fails to demonstrate compliance with policy SP7 which requires the development does not materially harm neighbouring residential amenity.

6. Conclusion

Although the principle of care provision is supported by Policy LP10, the proposal fails to comply with key requirements relating to:

The protection of Safeguarded Open Space (HP4).

Adequate car parking and highway safety (LP10).

Protection of village character and residential amenity (LP10 and HP4).

For these reasons, the Parish Council respectfully requests that the application is refused.

Waiting for an answer to prayers

It can be hard to know why prayers aren't answered immediately or in the way in which we've asked. Sometimes, looking back on our lives, we may understand why God has not answered prayer in the way we expected. We can't limit God or put Him in a box of our own imagination. The basis of all prayer should be trust – and that can be very hard at times, especially when we are in the depths of grief, having lost a loved one. When life seems very difficult the Surrender Prayer can be a very powerful way of handing over our problems to God: "Jesus, I surrender myself to you. Take care of everything." Repeat it 10 times – or more, if necessary! It's especially helpful when you're worrying about something, or

someone, in the middle of the night. You can also find online the Surrender Novena, which you can pray over 9 days. *Jesus I trust in You.*



Volunteer Accounts Examiner Required

The current volunteer examiner for the village hall annual accounts is shortly to move from the village, which will leave a vacancy for this key role before the end of our financial year on 31st March 2026. A volunteer is thus sought to fill this appointment as a matter of urgency.

The role involves reviewing the village hall annual accounts, which will have been prepared for examination by the village hall treasurer at the end of the financial year. The aim of the review is to confirm that, to the best of the examiner's knowledge, the accounts represent accurately the current financial position of the charity. This process is not a formal audit and the examiner needs only as a minimum to

be a 'competent' person with a basic knowledge of cash accounting. No formal qualifications are required and suitable candidates are likely to include active/retired owners of small businesses, current/past treasurers of local organisations, those with some experience of running a cash account and accounting professionals. Total time commitment is likely to be no greater than 12 hours during the auditing period, with all activities being undertaken during the month of April.

THE PRIORITY SERVICES REGISTER

If you are not aware of the Priority Services Register, this may be of interest to you or someone you know.

The Priority Services Register (PSR) is a free UK-wide service offering extra help during electricity, gas, or water supply interruptions.

You may be eligible if you or someone in your household relies on medical equipment, has a disability, long-term illness, dementia, mental health difficulties, refrigerated medicines, is of pensionable age, or has children under five.

Support during a power cut can include:

- A 24/7 priority contact number

- Text and voice alerts about local outages and severe weather
- Tailored support such as home visits, hot meals, welfare checks, and updates for family or friends
- In some cases, hotel accommodation and transport
- On-site community support with hot food, drinks, Wi-Fi, and charging points during major outages

To join the PSR, contact your local electricity network operator, gas distributor, and water supplier, as each runs its own register. You can find your providers using your postcode on the Energy Networks Association and Water UK websites, then apply online, by phone, or by post.

Also at The Great Bromley Cross Pub is a Bleed Kit. The kit, provided by Great Bromley Parish Council, contains specialist equipment to help stem extreme blood loss before ambulance crews arrive.

Bleed control kits, also known as emergency trauma packs, are similar to first aid kits but include trauma dressings, gauze, chest seals and tourniquets to help stop serious bleeding. They can help victims of violent crime, those involved in road traffic accidents or workplace accidents, and could be particularly useful in rural areas where ambulance response times may be slower.

Essex Highways carry out regular inspections of roads and pavements, but issues may come up between these inspections. These could be potholes or other road surface issues, damaged street lights, street signs, overgrown trees, or issues with public rights of way.

It has been an extremely busy time for the Parish Council this past few months!

Firstly, we want to say a huge thank you to Dawn for all her work and support over more than a decade as our Parish Clerk, a role she undertook purely as a volunteer, without ever taking payment. We are extremely grateful to her for everything she has done for the Parish Council and for the Village.

The Government has now announced the date on which Tendring District Council and Essex County Council will be abolished and all further elections have been suspended, meaning existing Councillors will remain in post until a new single-tier structure is in place, even though the Government has not yet decided what form that will take! In the meantime, parish councils remain the only properly functioning form of local government in Essex, adding to our responsibilities!

The costs of running the Parish Council keep escalating as ever more bureaucracy is imposed upon us. We are forced by law to pay a registration fee to the ICO (Information Commissioner's Office) just because, according to the ICO, the Parish Council is an organisation that processes personal information, although there is zero benefit to the residents of the village for that expenditure. We intend to complain to the ICO that charities are exempt from payment, so we feel we should be too!

We are also having to develop a new website and switch to .gov email addresses to ensure compliance with new government guidelines and are having to budget accordingly, and we are about to start the process of updating all the Parish Council's policies and procedure rules. An Extraordinary Meeting of the Parish Council was held on 8 January, at which we appointed Lizzie Ridout as our new Interim Clerk as well as agreeing the budget for 2026/2027. This year we have had to increase the precept (the amount residents have to pay with their Council Tax bill) by a huge amount in percentage terms in order to meet our budgetary commitments, even though our running costs are still one of the lowest of any parish council in the county.

Just before Christmas we delivered a survey questionnaire to every house in the Village about the Neighbourhood Plan, and we are delighted that there has been a tremendous response. A first draft of a proposed plan will emerge shortly based on the responses we received.

Our next Parish Council Meeting will be held on Thursday 19 March at the Haywain commencing at 19:30. We look forward to seeing you there.

MAUREEN JANE MORLING (née Sparrow)

5th June 1937 – 1st November 2025

Maureen was born to parents Kate and George Sparrow in Hare Green, Great Bromley, the youngest of three children, following her sister Sylvia and brother Peter.

She attended Great Bromley school during the war which left many people homeless. When the Sparrow's home was condemned, they moved into the RAF camp (behind Hamilton Lodge) that became one of many military bases used to provide temporary housing after the war. Maureen recalled the move with great excitement

because they had electricity for the first time – the children got told off for repeatedly turning the lights off and on! There were not enough clothes lines to go round, so Maureen's mother would go out late at night to be first to hang the washing ready to dry the next day.

When her Dad began working on a farm in Little Bentley the family moved to Pelham's Corner. Another new job for him meant they moved back to Balls Green in Great Bromley in a bungalow named "Wilmacott". After some renovations were carried out, Maureen was delighted to have her first ever proper bath with running taps at home! One of her fond memories was of wet Sunday afternoons when the children would ask her Dad if they could look through his treasured and well-worn photo album, showing pictures of him on horseback in the Royal Hussars at the end of the First World War.

In 1955 a handsome young German moved to Little Bentley with his mother. It was at a local dance that Maureen met Rudi. He spoke no English at all, so communication was a challenge. However, after a short time, a romance developed and they got married in June 1956. Maureen was a devoted wife and wonderful mother, bringing up her two boys, Ingo and Dean, on limited housekeeping money. The family had many happy times together, going on holidays to Germany to visit the places where Rudi grew up. They moved to Colchester where there were more job opportunities. She tried many different types of work through her life and liked nothing more than to have conversations with people she met - she loved talking to anyone at all, and was always very much a chatterbox! Sadly, there were many strains on the marriage and in the early 70s Maureen and Rudi were divorced.

When Maureen was in her 40s, she met Robert Morling, known to all as "Good Old Bob". They married in June 1984 and enjoyed many happy years together in



Elmstead Market with their little dogs and lovely garden. In Maureen's later years she volunteered at charity events in the community. She would frequently come back to Great Bromley for Village Hall and Church events.

Maureen was very humble by nature and didn't need a lot in life to be happy. Nothing was ever too much trouble for her, she was always happy to help wherever she could. She shall remain forever in the hearts of those who knew her.

A post is circulating on social media which claims that women born in the 1950s are about to win back the right to retire at 60, and that a major court case is happening in June. This information is incorrect.

The "Back to 60" campaign did take the Government to court, but this happened in 2019, and both the High Court and Court of Appeal ruled against the claim. There is no new court case, and therefore no "media blackout".

The State Pension age was raised and equalised for men and women through

laws passed in 1995 and 2011, and these changes remain in place.

The Parliamentary and Health Service Ombudsman has looked at how the changes were communicated and found some administrative failings, but this does not affect the pension age itself.

If you see the post being shared, please be aware that it is outdated and inaccurate. For reliable updates, check official sources such as the DWP or the Ombudsman.

CLOSURE OF THE CROSSMAN CHARITY 1792-2025

After more than 230 years of operation the charity 'Reverend Henry Crossman's Bequest' was closed by the trustees in November 2025.

Henry Crossman was born in 1711. He attended Emmanuel College, Cambridge, and was ordained deacon at Norwich in 1731. He was appointed Rector of Little Bromley in 1736, and also Rector of Little Cornard, Sudbury in 1744.

He wrote several devotional and instructional books. He was very worried that the masters and parents in rural areas were only concerned with the work provided by their servants and children. He wanted those in power to encourage them to attend their local church and "to have knowledge of God and their duty".

'Campaigning Cleric', an article of 1989 by Allan W Berry, gives a biography of Crossman and the controversies he was involved in. (ref. ISBN 0 9512755 3 4).

In 1760, after living in Little Bromley for 24 years, he moved back to Sudbury. In 1768 his daughter Elizabeth married Edward Green of Lawford Hall. His wife died in 1790 and he went to live with his daughter and son in law.

Rector Henry Crossman served Little Bromley until he died in 1792 aged 81 years. He was buried at Little Bromley where a tablet in the chancel commemorates his 56 years as Rector.

The Charity 'Reverend Henry Crossman's Bequest' (Charity 310785)

was founded by his will made in 1790. The income from £100 of 2 1/2% Consolidated Stock was to be used to support the Sunday School at Little Bromley and to provide yearly, a copy of the Founder's book, 'Explanation of the Catechism'.

In 1992 the Reverend Paul Davies, trustee, had the object of the Charity changed. Little Bromley Church had been closed and the Parishes of Great and Little Bromley united. There was no longer a Sunday School at Little Bromley and the Founder's book had not been in print for over a century. The Charity Commission agreed (1993) that the Charity could now provide copies of the Bible for the pupils of Great Bromley C of E Primary School.

In 2024, it was agreed by the remaining Trustees of the Charity, that with an annual income of around £22, it was sensible to close the Charity.

In November 2025 the Charity finally closed. The COIF Investment Shares had been sold which enabled the Trustees to give the school over £800 for the purpose of purchasing bibles or related Christian resources for the children. The school has now received all the monies from the Charity.

How wonderful that this Charity has been able to help the Parishes of Little and Great Bromley for so many years.

RECTOR'S LETTER

Dear Friends,

As February arrives, we find ourselves once again on the threshold of Lent, a significant season in the Christian Calendar marked by Reflection, Repentance, and Renewal. This year, Ash Wednesday falls on 18th February, inviting us to pause and consider our everyday actions and attitudes in daily life – a good discipline for everyone whether they have a faith or not. In our parishes, we will mark Ash Wednesday with services of Holy Communion, offering all an opportunity to receive the imposition of ashes and reflect together. The imposition of ashes is being marked in ash with a small cross on our foreheads, made from last year's Palm Sunday crosses.
