# LT BROMLEY PARISH COUNCIL

The following matters were discussed at the Parish Council meeting held on 6th October, 2011.

There were 8 members of the public present. The District Councillor was not in attendance.

Disquiet was expressed over the possibility of the gravel pit going ahead. Requests that the minutes be published on the website and that those that wished it to email addresses.

It was reported that there were two untaxed vehicles on the car park and they have been reported. The speed watch team informed us that they had executed five speed checks since the last meeting and some 60 vehicles had been reported. Also speed monitoring is to be conducted in the village.

The village has been crime free over the period.

War Memorial. A raffle of a TV set presented by Sylvia Downes raised some £243 for the repair fund which now stands at £1,277. It is hoped that work will commence shortly.

As far as the Bus Shelter is concerned there is some delay! We await authority of Housing Department. The fete and car boot sale was a bitter disappointment to all concerned; so much hard work for little return, poorly supported it raised only £88. It was agreed that other means of raising money should be looked at, i.e. Quiz Nights and Racing Nights etc, so get your thinking caps on and see if we can find something original to do. All moneys made go to help pay for the Firework night next year and that is usually so successful.

Planning Application for a cart lodge at the Old Vicarage. No objections.

Closing of local police stations has caused concern to the council about the number of

stations about to be closed in the area. It is hoped that at the Chief Constable's conference to be attended by Steve Wilcox less stringent choices can be made.

Regretfully Mary Roughley has decided to stand down from 31st December, 2011 due to business commitments. She will be sorely missed but has promised to continue her support of Little Bromley in any way she can.

A notice will shortly be placed on the notice board with details for applicants.

The Annual Report has been returned and there were no observations and approved by the Council.

The date of the next meeting was confirmed as the 8th December, 2011.

## HOUSEHOLD WASTE AND RECYCLING COLLECTION SERVICE AND STREET CLEANSING SERVICE

Tending District Council is in the final stages of awarding the new contracts for the household waste and recycling collections and street cleansing services. The new contracts will be awarded to Veolia ES (UK) Ltd (the current contractor for these services).

The street cleansing service includes for a frequency based sweeping and/or litter picking of all public roads, footways, car parks, council housing areas, beaches, promenades, greenswards etc and the emptying of all litter and dog waste bins. This contract will commence on 1<sup>st</sup> January 2012.

The household waste and recycling collection contract will commence on 1<sup>st</sup> February 2012. The new service will include the continued weekly collection of residual waste in black sacks – with black sacks being delivered to residents in the first 3 months of each year. The recycling collection service will be altered with the provision of a new red recycling box for all residents; this will then allow the collection of paper and cardboard one week in the red box

and in the second week the collection of cans and plastic bottles in the existing green boxes. Each household will also be provided with containers for the weekly collection of food waste. Two containers will be provided; a small kitchen caddy and a larger kerbside caddy for presentation of food waste for collection. The new collection service will be rolled out in April/May 2012. All residents will receive advice about the new collection services.

Full details about the new services will be on the Councils website including full street cleansing schedules and waste collection days.

Joint award of these contracts to Veolia ES (UK) Ltd has resulted in an annual financial saving to the Council of £564,000.

The Council would be pleased to receive the support of your Council in implementing the new services including the dissemination of information to residents.

the Hall. Last year we swapped electricity supplier and reduced our bill by 40% and this year we have swapped our insurer, got better cover and saved a huge amount. Thank you all for your help and support. What we need is a Youth Club in the Village and some one to run it, anyone interested? Anyone like to help or who would like to get something started?

Jobs still outstanding are roofing insulation and the interior painting for which we will need volunteers.

It is looking very likely that we will be installing extra protection for the oil tank before we put any oil in it for the winter. We have had one attempted break in already and with oil prices not set to get any lower the Committee thought it wise.

## IN THE GARDEN IN NOVEMBER

One of the jobs you can do this month for next year is to take out a trench, a spade wide and a spade deep, between now and next April, throw all your kitchen waste and compost into it to rot down for your beans and peas. When the trench is nearly full replace the soil on the top, your peas and beans will love this, it will also hold the moisture.



Start to harvest brussel sprouts, use the tops first then pull up one at a time as required and hang upside down in the greenhouse or garage.

As soon as the dahlias have been touched by the frost, dig them up, shake off the soil, give a dusting with sulphur powder which will keep the mildew at bay, then store in the greenhouse or shed in cardboard boxes.

Stop feeding house plants and keep the soil just damp, give them plenty of light but removed from window ledges at night.

Angela Brakeway was our very knowledgeable speaker on the subject of "The Bayeux Tapestry". She first spoke about the story of events that led up to the Norman Invasion in 1066. Before then England had already been invaded, so we were a very "mixed bunch"

Who commissioned the tapestry? Probably the Normans and Bishop Odo around 1070. It is NOT a tapestry but is embroidered in eight separate sections on unbleached linen and then sewn together. It is 230 feet long and 20 inches high. It very much shows the sewing skills of English women who were known to be much better than the French counterparts at this time.


The embroidery was probably carried out in the South East of England most likely Kent. The Designer of the tapestry is unknown possibly English. The threads that were used were woollen in eight colours, the older materials and threads have stood the test of time much better than the more modern threads and materials used for repairs. The script at the top is in Latin, but

it is not known who wrote it. In the various scenes, of which there are 73, the first 42 are in black and the rest in alternating colours. Angela really brought history alive and recommended that if you haven't visited this, it is one you should do.

Angela also told us that to this day our present Queen still holds the title Duke of Normandy. Finally finishing with thought for the day, Should the tapestry come back to England?





They often do frequent the recreational park, using the skating/biking area, as well as playing football. They only ever show the upmost respect and I'm sure would feel very upset if they ever caused worry or annoyance to their neighbours. They are all, or have at some point been, educated locally and are taught the value of respect for others, especially their elders. I feel they should be encouraged to enjoy their youth in their own street, as I was, especially as in many corners of the country they would not be afforded such a luxury.

## **Dear Editor**

Further to the letter published in October, may we take this opportunity to provide your readers with the facts about Little Dragons Pre-School's plans to operate from Church Meadow Bungalow. This may help dispel some of the rumours circulating in the village.

**Government Policy** – On 7th October 2011, Ministers announced help for less well off parents to enable them to go out to work, by introducing enhanced childcare support. Our plans directly support Government policy, by providing more flexible childcare thus enabling parents to return to the labour market. Our plans also secure the future of Little Dragons Pre-School.

**Use of the bungalow:** The owners of the bungalow are not seeking planning permission for change of use to commercial premises. What has been applied for is for use under Use Class D1 non-residential institution. This is the same use as churches, parish halls, libraries, clinics etc.

**Use of the land:** Another business cannot move in with little or no approval. The deeds of the bungalow contain a covenant which expressly states that the premises cannot be used other than as a private dwelling house or children's nursery/pre-school. Rumours about use of the land are therefore fundamentally misleading.

**Noise and traffic:** There will be a maximum of 24 children registered at Little Dragons Pre-School. The children will benefit from structured, supervised outdoor play. The play area has been moved to the rear of the property to meet one neighbour's concern (as was the reduction and

relocation of on-site parking spaces). Putting this into perspective, there are approximately 120 children at St George's School, which is about 150 metres away. The school and neighbouring properties are situated on a busy "B" road (Hall Road).

The operation of Little Dragons Pre-School will not lead to any noticeable increase in traffic or pressure on existing public parking. On average we expect up to seven parents/carers to drive and drop off/collect children from Little Dragons Pre-School. However, the arrival and departure times will be staggered and will not therefore be exactly the same as Leonard Cheshire staff or school traffic.

**Demolition:** To repeat what we said in May; the Bungalow is not being demolished. This was never on the agenda.

**Opening Times:** The proposed opening times of Little Dragons Pre-School will be from 08.00 to 17.30. Opening times of 7am to 7pm have never been on the agenda.

**Fencing:** The fence that has been erected around the bungalow is an outer boundary fence only. A secondary inner fence (yet to be erected) will provide a secure and safe play area for the children.

**Affordable housing:** Affordable housing relates to social rented and intermediate housing, provided by the local authority or housing associations, to specified eligible households whose needs are not met by the local market. Privately owned houses – even if currently rented at below market rates – do not constitute affordable housing.

**Support:** The Regeneration Team at Essex County Council view the project as "a highly valued community facility" and they believe "the rationale behind the relocation is based on sound and balanced business and community reasoning". The evidence suggests that concern being expressed is from a very small minority, whereas we have lots of evidence that there is a significant majority who actually support the application and use. With the backing of Essex County Council and so many hard working and respected local people, we are confident that we will deliver the kind of childcare every child in our community deserves.

**Future of the Pre-School:** Little Dragons Pre-School has been in existence and operating successfully for 34 years. We have a 15 year lease agreement with the owners of the bungalow. Our business plans have been scrutinised by Essex County Council – The

Directorate of Schools, Children & Families Early Years and Childcare are supporting our plans with a cash grant. Many other local businesses and tradesmen have also pledged their support, making this a true community project.

**Leonard Cheshire:** The Chairman of Leonard Cheshire in his latest annual report (2010/11) commented that Leonard Cheshire continues to face challenges – in addition to spending cuts, they have to contend with the harsh economic climate. As part of its review of properties and land, Leonard Cheshire privately sold one of its bungalows (and land, solely owned by Leonard Cheshire) at full market value to an investor who purchased it for Little Dragons Pre-School. The sale of any Leonard Cheshire assets and decisions on how the money is used is a matter for their senior leadership team and trustees. Both Leonard Cheshire Seven Rivers and Little Dragons Pre-Schools will directly benefit from new partnership initiatives that are building between the two organisations.

**Councillors:** We hope very much that you will support us in what we truly believe will be a wonderful, much enhanced, community resource and we encourage you to write to your elected official expressing your views, requesting that they represent these and the views of the significant local majority that clearly do support the application and use.

**Dear Editor**

As someone who served as a Parish Councillor for Great Bromley for over ten years I feel that I must write to clarify the position of the Parish Council in relation to Planning Applications.

The Parish Council's role is very limited. It receives details of Planning Applications in Great Bromley as part of the consultation process undertaken by Tendring District Council for all Planning Applications. Its role is to consider them, make comments and recommend that TDC approve or decline an application. It has no power to approve or decline an application itself.

That is the sole prerogative of TDC as the Planning Authority. All decisions by the PC must be made on planning grounds and any recommendation to TDC to decline an application must set out the objection on which the decision is based i.e. over development, outside the village envelope etc. Increased traffic movement or noise levels are not in themselves grounds for declining an application although the PC may recommend that TDC take such matters into consideration in their decision.

As already mentioned TDC is the Planning Authority. As required by the Government, at least 90% of all planning decisions are made by Council Officers under delegated authority from the Planning Committee. The Officers may recommend that some applications, for example the Tesco Store in Manningtree, are considered by the Planning Committee at one of its monthly meetings. In addition, District Councillors can 'call-in' an application for detailed consideration by the Committee,

TDC in considering an application will call on the views of Essex County Council, as highways authority, Anglian Water and other public bodies who may have an interest in the application. Having approved an application, it may impose conditions on the approval to meet objectors' concerns. An application which has been declined must state the grounds on which it has been declined. In such an event the applicant has the right to appeal the decision in which case the matter is referred to the Planning Inspectorate whose decision is binding. Objectors to an application, which has been approved by a Planning Authority, do not have the right of appeal although, at their cost, they may request a Judicial Review of a Council's decision. Should the review fail then they will be liable for all the legal costs.

All Councillors, Parish and District, are governed by a Code of Conduct which, in respect of planning applications, requires that they declare an interest in a proposal if they are affected by the application and take no part in the decision making process. District Councillors on the Planning Committee, when an application in their ward is being considered, must declare an interest. Thus Councillor Heaney, as Chair of the Planning Committee, would have to, and has done so in the past, excuse herself from the meeting whilst an application in the Great Bromley and Frating ward is considered. Councillor Nicholls is not a member of the Planning Committee and would be able to speak at the meeting if he so wished. However, he

would have to declare an interest if he or any organisation of which he is a member of the committee is affected by an application.

Whilst public attendance at a Planning Committee is encouraged participation is somewhat limited. Anyone wishing to address the meeting must give notice to the Committee and is limited to a time of three minutes. Having listened to the submissions, the members of the Committee will discuss the application and reach a decision, for or against the proposal, by a show of hands.

## KITCHEN CORNER

### Smoked Haddock Soup

8oz smoked haddock  
1 onion, peeled and finely chopped.  
600ml/1pt water  
600ml/1pt milk  
Seasoning  
8-12oz hot mashed potato  
1oz butter (flavoured with lemon and parsley if available)  
1 Tbsp lemon juice.

Method. Put fish in a saucepan with onion and water, cover and simmer gently till tender, about 15 minutes. Remove fish, put skin and bones aside and flake the flesh finely.

Return skin and bones to pan and simmer 10 minutes. Strain the liquor into a clean pan and add fish, milk, seasoning (not too much salt) bring back to the boil. Simmer 3 minutes then whisk in mashed potato to make the consistency you like. Stir in the butter and lemon juice, and serve very hot with toasts or croutons.

## NATURE'S DIARY



This is the month of whizzes and bangs as people enjoy Firework parties. Do keep you cats and dogs indoors. I used to have a dog years ago who was terrified of thunderstorms and fireworks, even when she was indoors. She would cower and shake in a corner until it was all over. Be aware also that hedgehogs may be hibernating in piles left for bonfires and check before lighting them.

The first frost has been and gone after a late warm spell and now suddenly heating is required along with warmer food. Spare a thought for the wildlife outside. There are still berries and seeds to be found at the moment but extra food in your gardens, throughout the winter, will help sustain them through the long cold days to come. Don't forget to leave out fresh water for them to drink and to bathe in.

The summer migrants have left and the winter migrants are returning – look out for the winter thrushes (the redwings and fieldfares) in the fields and trees. They particularly like the berries of the hawthorn. To see the waders and wildfowl

migrants go along the river at Manningtree where many of them can be seen. Starlings will be massing together providing spectacular watching as they prepare to home in on their favourite roosting site.

The insects will also be preparing to hibernate in nooks and crannies, sheds and, sometimes, our houses. Ivy is a winter refuge for many insects with the consequence that wrens, who are insect eaters, quite often reside there as well – fast food to hand!

The toads will now be hiding beneath logs and stones for the duration of the winter so keep a careful eye open when gardening whilst frogs will hibernate at the bottom of ponds ready to emerge in the new year.

Life appears to be dormant but much is going on under the surface if you just stop and watch.

## “Seven Rivers” - why, “Seven Rivers”?

More mental meanderings on how Leonard Cheshire came to give us our distinctive name.

### **Birthplace of a Religion**

Eastwards, first, to the area of the Punjab, where it straddles the borders of northwest India and northern Pakistan. These are lands, stretching as far as Afghanistan it is said, where the Hindu religion first grew up. The tales told in the area for generations spoke of the rivers' release from the mountains and there are many myths surrounding the “*Sapta Sindhu*”, which means “Seven Rivers” in the local language.

### **A Mystical Land**

Next, we move to the mystical land of Lindon, as created writer J.R.R. Tolkien. He wrote books called *The Hobbit and The Lord of the Rings* about an elf called Bilbo Baggins and his adventures in the mystical world of “Middle Earth”, where Lindon lay .

Within this place, there was a “Land of the Seven Rivers” as the story tells, where a tribe of elves called the Laiquendi dressed all in green in order to blend in with their forest background, and became famous for their stealth and secrecy.

So, I wonder, could any of these stories and places, related this month and last, have given Leonard Cheshire the idea for the name of our home?

Could he have been inspired by the story of a Mexican ghost town peopled by ghostly bandits of the wild west era? Hardly!

Scottish Highland dancing or American scouting adventures? The beauties of the Mississippi river valley? A good game of golf? Probably not.

Perhaps we shall never know.

But we do know that Leonard Cheshire loved India and did great work there, beginning in Mumbai (or Bombay as it was then), where he opened a Home in 1955 ( just three years before Seven Rivers came into being). This

city is within reach of the area of the Sapta Sindu - and he was also a very religious man.

We also know that Tolkien's Lord of the Rings was first published in 1955, just at the time that his own children were growing up. Perhaps he shared the adventures of Bilbo Baggins in the lands of Middle Earth with them? Maybe the idea of little people dressed in green and hiding in the woods caught their imaginations?

Certainly, he viewed the world of disabled people as being a secret world as he described in his book, “The Hidden World”, written in 1981, in which he says, “...it [the world of disabled people] is a world that, even to this day, is little known and poorly understood. This is true to such an extent that I have come to think of this as a ‘hidden world’...”

Who knows? “Seven Rivers” – I wonder....

The Office of Fair Trading is warning people of unscrupulous traders that sell mobility aids on the doorstep. Mobility aids are products that are used by the elderly or disabled such as mobility scooters, wheelchairs, and walk-in baths. These items are often sold to vulnerable people in their home. A charismatic salesperson can be intimidating and it is easy to fall for their charm. This is a skill often used by rogue traders, to convince you to buy a mobility aid you may not need, or agree to terms you haven't fully checked out. Office of Fair Trading's campaign, which is offering people advice on how to deal with rogue traders, seeks to ensure you don't end up committing to pay for something you haven't had the chance to fully consider first. Consumer Direct, the OFT-managed advice service attracts a large number of calls from people complaining or asking for advice about mobility aids and in 2010, over 4,500 such calls were made. It is not illegal for traders to canvas for work in this way but it is important that people are cautious and don't make hasty decisions about agreeing to have work done by traders who come to their doorstep. Rogue doorstep trading is an ongoing problem in the UK and mobility aids sold to people in their home can sometimes be unnecessary, of a poor standard, and much more expensive than originally quoted.

If you think people who fall for scam letters are stupid, Think Again!

Criminals worldwide are sending millions of **scam letters** into the UK. After replying to the first 'tempter' letter, victim's names are put on a 'suckers' list; these lists are then sold to other criminals all over the world.

A chronic scam victim is someone who is repeatedly taken in by scams. This may be because they are over trusting, socially isolated, suffering from declining mental health or dementia. Some victims are receiving 30/40/50 over 100 criminal letters a day. 22,000 victims replied to one scam mail shot in one day and sent £500,000. 20 pensioners in Cornwall collectively sent £350,000 to another!

I have received a letter from a member of the public in relation to a letter received. I would advise that should anyone receive a similar one then please either report it to action fraud [www.actionfraud.org.uk](http://www.actionfraud.org.uk) or Tel 0300 123 2040. The letter is from a Mr Chen Wong who claims he works as an external auditor in an Asian region and has come across information on a possible relation (who has the same surname as you) and that 29.8 million United States dollars could be yours. The male claims that he can secure the funds for you and all you need to do is to contact Mr Wong direct. This letter looks as it has been posted from the UK. Many people would simply dispose of these types of letters in the bin, but unfortunately many people are still victims of these scams. If you have any concerns please contact Essex Police 0300 333 4444.

### Microsoft scam survey

To establish the extent of this emerging form of Internet fraud, Microsoft surveyed 7,000 computer users in the U.K., Ireland, U.S. and Canada. The survey showed that across all four countries, 15% of people had received a call from scammers. In Ireland this rose to 26%. Of those who received a call, 22%, or 3% of the total survey sample, were deceived into following the scammers' instructions, which ranged from permitting remote access to their computer and downloading software code provided by the criminals to providing credit card information and making a purchase. The vast majority (79%) of people deceived in this way suffered some sort of financial loss. Seventeen percent said they had money taken from their accounts, 19 percent reported compromised passwords and 17% were victims of identity fraud. More than half (53%) said they suffered subsequent computer problems. The average cost of repairing damage caused to computers by the scammers was more than £1,000.

### The following is Microsoft's advice:

- Be suspicious of unsolicited calls related to a security problem, even if they claim to represent a respected company.
- Never provide personal information, such as credit card or bank details, to an unsolicited caller.
- Do not go to a website, type anything into a computer, install software or follow any other instruction from someone who calls out of the blue.
- Take the caller's information down and pass

it to the authorities.

- Use up-to-date versions of Windows and application software.
- Make sure security updates are installed regularly.
- Use a strong password and change it regularly.
- Make sure the firewall is turned on and that antivirus software is installed and up to date.

Please be aware that Microsoft does not cold call offering repairs.

**Microsoft advises anyone who thinks they may already have been a victim of a phone scam to do the following:**

- Change their computer's password, change the password on their main email account and change the password for any financial accounts, especially bank and credit cards.
- Scan their computer with the Microsoft Safety Scanner to find out if they have malware installed on their computer.
- Contact their bank and credit card companies.

Anyone who has been a victim of this type of fraud should report it to action fraud.

I have also received information which indicates that several people are receiving emails or phone calls regarding the following items.

**Tax refunds** – This looks like an official HMRC site. They may state you are owed a tax rebate. Or that they will look into the fact that you have overpaid your tax and can claim this back for you. Please **do not** click the link button and do not fill in any personal or banking details. Nationwide, thousands of people have reported receiving this scam.

**Western Union** – Again this looks genuine, it claims that as a customer you need to update any records that they hold for you. Do not linkup or again give any details.

**Council Tax** – Calls have been received whereby you are told that you could be entitled to a council tax rebate. There are some companies that will look into this for you and they will take a percentage any money that you have been overcharged. That is fine if you want someone to look into this for you. However if you think that your Council tax is wrong you can visit your local council office in person and they will look into this free of any charge. Some of the calls have a dialling code 00912 which is the code for India.

**Orange** - this email has been sent out to many asking you to update your records, it is not genuine. If you have queries regarding your phone please contact Orange direct.

#### **Alarm systems phone calls**

Calls are also being received by companies who indicate they are involved in Crime Research or Crime Prevention; they may state they are a crime reduction liaison officer / advisor and that there has been a rise in the amount of burglaries within your area. Some companies may also claim that they also work in conjunction with Essex Police, well they do not. You may be offered a free alarm or one for a £1.00 and they will attempt to make an appointment to show you their product. It is best not to get involved.

Never feel pressured into signing a contract, if something does not feel right, do not get involved.

# THE RECTORY, GREAT BROMLEY

Dear Friends,  
Oxford of course was a marvellous experience and I was tutored and lectured by some of the top theologians of the day. The study of Theology can sometimes undermine one's faith as many of those things, which were once certainties, are brought into question. My training as a student of history had shown me that even historical facts were liable to interpretation and as we were dealing in theology with things unseen, there is much that is mystery, myth and liable to interpretation. During my time at Oxford the great controversies began with the publication of "the myth of God incarnate". The authors of this book were much maligned because of a popular understanding of the word "myth". Many of the authors themselves did not deny the fundamental truth behind the symbols and stories in the Bible, which were regarded as "myth".

My reading of theology did more to deepen my faith than to destroy it. Admittedly it changed some of my attitudes, but a faith built on fewer certainties was more of a faith and not less of a faith.

Oxford of course was a place where there was such a variety of worship to choose from. Where else, except perhaps Cambridge (referred to at Oxford as 'the other place!') could one choose where to go for a Eucharist or Evensong and choose between so many excellent choirs?

My two usual places of worship among of course several others were Pusey House and Christ Church Cathedral. The High Mass at Pusey House on a Sunday morning was a wonderful experience. I even got to play the organ there when the organist happened to be away or was taken ill. The singing was good. Each Sunday the preachers were distinguished theologians and spiritual men.

I usually went to choral evensong at Christ

Church Cathedral on Saturday and Sunday evenings.

During the first term of my second year my parents came to visit me at Oxford. They spent a lovely weekend seeing the city of dreaming spires. They returned home on the Monday and my mother was taken ill, but she assured me after a couple of days that she felt better, the Michaelmas term ended on December 8<sup>th</sup> 1975 and I travelled home to Wales. I had only been home for a few days and my mother was taken ill again. My father was at work. She stayed in bed all day long and this was highly unusual. I had never known her to do this before. Her face was turned to the wall and she told me the next day that now she was not afraid to die. I naturally told her not to be so morbid, and she laughed but repeated very seriously that death was not to be feared.

Then as Christmas drew nearer I was aware that my mother was not herself. Her strength seemed to have been taken away from her. I did most of the Christmas shopping and some of the cooking but she insisted on cooking the Christmas dinner. I was aware that something was wrong. My mother began to speak very candidly about many aspects of her life. We had always been so close but now she seemed to express her innermost thoughts. She became weaker and weaker. The doctor kept diagnosing flu or virus. It was now New Year's Eve. My father was at sea and although we always waited the New Year in I begged her to go to bed because she was so unwell. However she insisted on bringing in the New Year with me. The words she spoke that night were so prophetic and I cannot share them because they related to people and circumstances, which are personal. Suffice it to say I firmly believe it was her way of preparing me for her death.

I shall continue with the story next time.
